

PROF. DR. SENAD ĆEMAN



Dr. Senad Ćeman is an associate professor of Sharia Law (fiqh) and the head of the Chair of Sharia Law (fiqh) at the Faculty of Islamic Studies, University of Sarajevo. He got his bachelor's degree in Sharia Law from the Islamic University of Muhammad ibn Saud in the United Arab Emirates in 1999. He got his master's degree in 2008 and obtained his doctorate in 2017, both from the Faculty of Islamic Studies at the University of Sarajevo. Additionally, he completed specialized studies in Arabic language at the Institute of Arabic Language at King Saud University in Riyadh in 1991-1992 and 1994-1995. He also completed specialized studies in English language in 2018 at Glendale Community College (GCC) in the United States, Phoenix.

Dr. Senad Ćeman is the author, co-author, or translator of eleven books. Among his works are "Zbirka zadataka iz šerijatskog nasljednog prava" [Collection of Tasks in Sharia Inheritance Law] published by El-Kalem and the Faculty of Islamic Studies, University of Sarajevo in 2021, "Kratki ramazanski vodič o prehrani" [A Short Ramadan Guide on Nutrition] published by the Agency for Halal Quality Certification, Tuzla, in 2021, and "Vakufi i fondacije: komparativna studija o položaju vakufa i fondacija u šerijatskom pravu i pozitivnim zakonskim propisima u Bosni i Hercegovini" [Endowments and Foundations: A Comparative Study on the Position of Endowments and Foundations in Sharia Law and Positive Legal Regulations in Bosnia and Herzegovina] published by El-Kalem, Sarajevo, in 2011.
