Dr. Mustafa Hasani holds the esteemed position of a full professor in the field of Islamic law (fiqh) at the Faculty of Islamic Studies, University of Sarajevo. His academic journey commenced with his graduation in 1994, followed by the attainment of a master's degree in 2001. He culminated his academic pursuits with the successful completion of his doctoral studies in 2011, all of which transpired at the Faculty of Islamic Studies, University of Sarajevo.

Dr. Hasani's scholarly contributions are marked by the publication of numerous original works, notable among them being the book entitled "Hajj in the Contemporary Social Context: Sharia Legal Challenges in the Era of Increasing Numbers of Pilgrims."

His academic and research endeavors are primarily focused on the domains of Islamic law (fiqh), devotional rituals (ibadat), Islamic family law, and the issuance of legal opinions (fatwas).
