

PROF. NEDIM BEGOVIĆ



Dr. Nedim Begović is an associate professor of Islamic law and jurisprudence (fiqh) and vice dean for quality assurance at the University of Sarajevo - Faculty of Islamic Studies. He graduated in Islamic theology in 2005, and received his master's and doctorate degrees at the University of Sarajevo - Faculty of Islamic Studies in 2011 and 2014, respectively. As a Fulbright researcher, he spent academic year 2011/12 at the UIC John Marshall Law School in Chicago, the United States where he conducted research on religious freedom in the case law of the European Court of Human Rights.

He is the author, co-author or translator of more than twenty books.
